Menlo Park resident creates moving billboard

With the election just days away, one Menlo Park resident isn't resting until as many San Mateo County residents as possible know to vote against controversial Measure A. Dorsey Nunn will be crisscrossing the county this weekend in a van decorated with a simple message: "No Jail Tax". "I am tired of elected officials prioritizing imprisonment over education, jobs, healthcare and other services," says Nunn. "I am tired of the county crying broke when we call for services and programs that help our community then suddenly wasting hundreds of millions of dollars to build a new jail to lock up those people instead. I am sick and tired of the damage this does to San Mateo County. And I'm not alone."

Nunn will be driving to neighborhoods, business districts, farmers' markets, and the site of the new jail to educate residents about Measure A's hidden agenda. Measure A, otherwise known as the Jail Tax, is a sales tax increase proposed by San Mateo County Board of Supervisors that would allot as much as \$30 million a year to staff a proposed new jail in Redwood City. As resistance to the jail construction has been growing, residents have expressed outrage over how the funding for the jail has been buried in

What NAM discovered is continued strong support for the incumbent. Much more interesting, however, are the reasons the media gave for their endorsement: While ethnic media editors cited Obama's policy positions and accomplishments during his first term, issues of race or identity politics were scarcely mentioned.

Following are excerpts of endorsements taken from a variety of Latino, Black and Asian media, with links to the complete articles and programs, where possible.

Vida en el Valle: "Obama deserves 4 more years"

Millions of felons denied voting rights

On Nov. 6, an estimated 5.85 million Americans could be kept away from the ballot box due to felony convictions, according to a report by a criminal justice re¬form advocacy group. The Sen¬tencing Project estimates 75 per¬cent of disenfranchised felons are no longer incarcerated.

The U.S. Supreme Court ruled in 1974 that states have the con¬stitutional authority to restrict voting by convicted felons.

The voting irregularities of the 2000

and 2004 presidential elections drew nationwide atten¬tion to the estimated five million Americans barred from voting by a variety of state laws that deny people with criminal re¬cords the right to vote — some¬times temporarily, sometimes permanently.

Voting rights of felons and ex-felons are restricted in 48 states. Maine and Vermont are the only states that extend voting rights to incarcerated Americans.

Californians can vote only after they get off parole; how¬ever, Pennsylvanians can reg¬ister to vote when they are re¬leased from prison.

Mississippi has 22 ways to disenfranchise potential vot¬ers. Stealing timber is one of them, while manslaughter is not. Disenfranchised Missis¬sippians who want their vot¬ing rights back must get the approval of two-thirds in both houses of the state Legislature, and then go through a guberna¬torial process that includes the power to veto.

If you distribute pornography in Alabama, you will be disen¬franchised, according to an on¬line article by

News21.

In Kentucky, ex-cons must get the approval of the governor to restore their voting rights.

"When people are punished for crimes that they've com¬mitted, that should not involve forfeiting their basic rights of citizenship, which is what felony disenfranchisement does," said Marc Mauer, executive director of The Sentencing Project.



Last but not the least, he chose his main opponent, Hillary Clinton as the Secretary of State -- she has been a strong voice in support of women, children and democracy throughout the world.


Sing Tao: "President Obama's plan could grow the economy in the next four years."

votes. During a GOP debate in Arizona in February, Romney said, "We're going to cut taxes on everyone across the country by 20 percent, including the top 1 percent." However, during the first presidential debate, Romney said that he would "absolutely not" support a plan that cuts taxes on the wealthy.

Romney said he would label China a currency manipulator on his first day in office. He also said that a cheap Chinese Yuan matters, because it gives China a competitive advantage, making it easier for Chinese manufacturers to sell their exports inexpensively. From the Editor's Desk

How will Californians vote on November 6?

Well, the nation is literally on "pins and needles," so to speak, wondering who will be elected as this nation's next president. Some political observers say that the presidential election has stirred up more excitement than past presidential elections have. I heard just today that the divi-

siveness in the country is such that whoever wins will leave half the voting electorate disappointed and even angry. In a few communities, the police departmight be ments preparing for riots to occur depending on Henrietta J. Burroughs which candidate loses.

According to the latest statewide statistics, there are 18.2 million Californians who are registered to vote in a statewide population where there are nearly 24 million who are eligible to vote.

The latest data from the San Mateo County Registrar's office shows that there are currently 361,486 newly registered voters in San Mateo County.

Of this number, more than half, 185,331, are registered as Democrats and 70, 346 are reqistered as Republicans. Of the total number of voters registered, 91,994 have registered with No Party Preference (NPP)

Looking at only the City of East Palo Alto, there are a total of 8,402 newly registered voters, which is a number that increased from the 7,297 who registered last year. Within these numbers, there are 5,401 registered Democrats and 729 registered Republicans with 1,986 who are NPP.

Surprisingly, these numbers are lower than they were in November 2008, when there were 6,295 registered Democrats and 1,2 85 registered Republicans out of a total of 10,034 newly registered East Palo Alto voters. In 2011, the number of registered voters dropped to the lowest number than it has been since the 2008 election.

These figures support the idea that more people come out to vote during a presidental election than they do during the primary elections.

One can get a lot of information by looking at statistics, assuming that they are accu-

This past October, the California Secretary of State's office released statistics showing that in the state as a whole, 43.7% of the voters were registered as Democrats, while 29.4% were registered as Republicans. In 2008, those numbers were 44.4% and 31.4% respectively.

In the 2008 election, there were 26 California counties where the majority registered as Democrats and 32 counties that had Republican majorities. This year 28 California counties have democratic majorities and 30 have Republican majorities.


In short, California is a state where Democratic voters outnumber Republican voters. But contrary to one report that I heard, it is too early to declare that the Republican Party in California is becoming an endangered species.

I don't generally write an article that has so many statistics, but the statistics speak for themselves when it comes to giving a picture of what is going on locally and in California as a whole.

East Palo Alto is changing and the State of California is changing. Given the numbers, it is quite clear why California is listed among the blue states. The presumption is that California voters will vote to re-elect President Obama.

Life is full of surprises, but another outcome in California is not expected to be one of the surprises we can expect in the upcoming November 6 election.

Given the fact that the presidential candidates are said to be running neck and neck in the race. the biggest surprise might be in which candidate will be selected.

Pulling the district from the "sewer"

Dear Editor,

Two articles have recently appeared in your paper regarding the East Palo Alto Sanitary District.

The first on October 1 was an article that reported on the 4-0 vote by the Sanitary District Board to censure one of its directors.

While as the president of the current board, I am appreciative of the attention your paper has found necessary to give the agency, it is unfortunate that the good work the board has done since the dysfunctional period that characterized the district's operations prior to 2002 has received little coverage.

We have as a board, working together, pulled the district literally from the "sewer", if you would excuse the pun.

The last few boards have brought back the district to financial solvency through astute financial stewardship as well as implementing capital projects that would in the long term save the district thousands of dollars.

For instance, the district' recently completed Sewer Rehabilitation project that refurbished a 24 inch 5,000 feet long trunk-line is expected to save the district an estimated \$180,000 per year. This in both reduced water flow to the treatment plant and operations and maintenance expenses.

The district was able to get a

\$1.7 million at 2% interest loan to complete the project, a loan possible only because of the excellent financial standing the district has.

We have restored the staff of the district to full time work after previous mismanagement had necessitated furloughs that in our mind deprived ratepayers of essential services because staff was not available.

Staff morale is high and the litigious environment that characterized the district in previous regimes is truly in the "sewer".

All of these achievements have been possible only because we have a board that generally works well together regardless as to who is the president. There are of course disagreements but the general expectation or rule that most directors abide by is that we can disagree but we do not have to do it disagreeably.

Directors on the board have full time jobs. As such it is very difficult for them to breakaway or take time off from their jobs frequently to participate in committee meetings. In an effort to be efficient with their time as well as to meet appropriately their obligations to their jobs and supervisors, the directors agreed to consolidate their meetings such that instead of taking time off of their regular work several times a week, they would schedule multiple district meetings on the same day. In making that decision the board and staff did not make note of the

state law and or the board's policies regarding the number of meetings that can be held on one day.

The board has since corrected the error.

On the second article, Directors have been encouraged over the vears to take advantage of district related conferences as a means of familiarizing themselves with the best practices in the area of sewer and special district management, environmental regulations, waste, wastewater treatment, recycled water etc. Information garnered and education received from these conferences only contribute to the pool of knowledge within the district, knowledge that can only better the directors' ability to serve the needs of residents in our district.

This encouragement has been inspired by several reasons, the most important one of which is that directors are elected officials! They get elected into office not because of their extensive knowledge of sewer services but because of their interest, as ratepayers, on having some control on how the services are provided to them. They, as such, may come with not as much knowledge of the details of their mandate. Conferences and workshops, associations with similar colleagues from all over the country are critical in making them into the effective directors

serves as the only medical care provider for many low-income woman and people of color.

Romney critics say his stance on Planned Parenthood constitutes a 'war on women', but in reality it furthers his stance on minorities and people of color.

Planned Parenthood provides breast, cervical and ovarian cancer screenings that save lives, it also provides prostate and testicular cancer screening for men; access to birth control and lowcost abortions to patients who qualify; and is often the only source for wellness checks many low-income men and women receive.

Romney also confirmed his desire to repeal the Affordable Care Act (ACA), signed into law by President Obama. The law is popularly known as ObamaCare. Romney wants to leave it up to individual states to create a health plan, which was the case before the ACA.

States had a difficult time delivering. To make matters worse, according to Seattle news site Crosscut.com, he wants to distribute Medicaid in block grants to states. Since children make up the majority of Medicaid recipients in forty-four states, minority children may be grossly affected. It also means a set amount of money for each state to deliver health care. Someone is sure to be left without coverage.

HOW IT WAS IN THE PAST

Elections are tricky and can be confusing, especially for first time voters. It seems tedious filling out the paperwork and election ballots need to be correctly filled out or else they may be discarded. And though it seems as if all citizens had the right to vote since the nation's inception, that is not true! It was only with the Voting Rights Act of 1965 that African Americans, Mexicans, Native Americans, the poor and Latinos became enfranchised with the right to vote.

Prior to that, U.S. citizens arbitrarily had their right to vote contested. In some cases, folks were denied the right to register to vote. And when they would show up to vote they would be told they could not vote if they were illiterate or in-Considering how numerate. schools back then did a poor job of teaching students how to read and how to count, that excluded many potential voters. Then voters were told they could not vote if they did not speak English and that again excluded many residents, especially those living in rural areas and on reservations.

And if that weren't enough, the final obstacle to voting prior to 1965 was the infamous poll tax. The poll tax. It prevented the poor from voting if they could not afford to pay and helped the rich elite leverage their numbers and maintain their status quo. And finally, the rich elite of the past used misinformation and discouragement as final measures that kept poor potential voters disorganized and confused about their rights.

As part of his Great Society initiative, President Lyndon B. Johnson fought to get the Voting Rights Act of 1965 legislated and passed. And because of that effort, all U.S. citizens today have the right to vote and the right to register to vote. # It is one of our many civil rights!

TODAY'S CHALLENGE TO OUR RIGHT TO VOTE

Unfortunately, twenty-three states are currently promoting



laws that would bring back all of the pre-1965 obstacles - along with all the veiled threats that go with them. And if that happens, the nation will regress to what it was before 1965.

So if there ever were a time to organize and vote, it might just be now. If this current trend of disenfranchising voters succeeds, then six million African Americans and ten million Latinos may simply lose their right to vote.

VOTE ON ELECTION DAY WITH A PROVISIONAL BALLOT

And yet there is hope. It is now possible to visit your voting place on election day and request a provisional ballot. Call San Mateo County's Clerk office at (650) 312-5222 to find out which voting location you need to go to. You can also talk with them in person at one of San Mateo County's two voting centers.

San Mateo County's voting centers: 555 County Center, Redwood City, CA and at 40 Tower Road, San Mateo, CA.

Now keep in mind that stopping in to vote on election day does not mean you get registered to vote! No! What it means is that San Mateo County election officials will provide you with a provisional ballot. Following the instructions of the personnel working at your voting place, you fill out the provisional ballot and turn it in. Now, if no one else votes using your name at your correct voting place, then your provisional ballot should be counted in this election.

So remember that if you ask for a provisional ballot on election day, you will not be registered to vote, which means you will not get called up for jury duty! Jury duty is a civic duty extended only to those who register to vote, because jurists only get assigned from the pool of registered voters.

To find out more, consider visiting one of the websites listed below. And remember that your vote is your vote and no one else's. You don't have to vote along party lines if you don't want to. But if you vote on local, state and national issues that are important to you, then you are exercising your civil right to vote, a right granted to all U.S. Americans in 1965.
